General Requirements:

Stage & Chairs



Chairs without arm rests should be arranged in a straight line. If space permits, leave room behind the chairs to be able to move around. Otherwise please set them against the back wall. Not required – but preferred. That chairs lock together or legs tied together front and back. Chairs set up on stage to seat min 15 people.

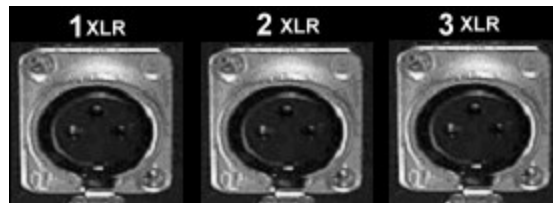
- Suggested minimum stage size is 10' x 16' - the bigger the better (this way it can accommodate more volunteers).

Lighting:

- Soft front wash. No Effects.
- No follow spot required, unless the venue warrants it.
- Adequate lighting and electrical hookups.

Sound:

- Professional sound system, with speakers, stands and chords.
- Playback sound monitors (speakers for the performer on stage) should be used wherever possible to assure crisp and clear sound for the participants.
- Dr. H carries and uses his own head set and hand held microphones. One extension chord will be required. Must be long enough to connect power strip to electrical socket in room.
- System input required. Must be able to connect to 3 XLR connections (microphone cable hookups) to sound system.



- **Small table for lap top.** Dr H. controls musical queues remotely through a laptop, which is plugged directly into the sound system. The laptop will be set on the side table.

Video:

- All **still photography** is highly encouraged. Please, take lots and lots of photos of your friends on stage.



AUDIO/VIDEO TAPING: Permission must be requested and approved in writing by Beyond Your Imagination, Inc. c/o Dr. H. No Exceptions. BYI will be filming and selling DVD's of the show. BYI retains 100% of all such sales included the (B.O.R.S.) sales. - All video taping of the performance is prohibited since Dr H sells his shows on DVD as part of his generated revenue.



Water:

- Six pack of non-chilled bottle water for performance. Please have someone check on these items well in advance of show time.
